#### **CONTEST RULES**

#### § 1 GENERAL PROVISIONS

- 1. The contest is organized under the name "Summer Postcard 2017" and is hereinafter referred to as the "Contest".
- 2. The organizer of the contest is B-craft Karolina Bąkowska ul. Aluminiowa 7, 70-725 Szczecin, POLAND.
- 3. The competition will be conducted exclusively on the Internet, on b-craft.pl website and on the B-craft Facebook profile.
- 4. The rules of the competition constitute the details of the regulations of the b-craft.pl internet shop. The rules should be treated together.
- 5. Each adult and any minor who has obtained parental or legal guardian's consent may participate in the contest.

## § 2 MAIN RULES AND REQUIREMENTS

- 1. The main task in the competition is to sew the original textile work using cotton fabric in any technic, in a broadly understood summer theme.
- 2. The format is strictly defined and must be 10 cm x 15 cm. These are exactly the dimensions of a typical postcard.
- 3. The submitted works can't be previously awarded in other competitions.
- 4. Each contestant can submit maximum 3 works.

### § 3 SUBMISSION OF WORKS

- 1. There are two options for submitting works:
  - you can send 2 photos of each work being submitted, one photo showing all work and the other with selected detail. Image resolution can't be less than 1600x1200px. Photos should be in JPG format;

or

- you can send the finished work to the Organizer's postal address.
- 2. Regardless of the manner of application described in §3 point 1, you must fill in and electronically submit an application form for each work.

#### § 4 EXHIBITIONS AND AUCTIONS

- 1. The submited work will only take part in the exhibition if the author wishes to do so, by filling in the appropriate entry in the entry form.
- 2. The submited work will only be auctioned if the author wishes to do so, by completing the appropriate entry in the entry form.
- 3. The exact place and date of the exhibition strictly depend on the number of submitted works.
- 4. The auction will take place at the end of the exhibition or during the exhibition.
- 5. The Organizer reserves the right to cancel the exhibition due to the small number of submitted works.
- 6. The total proceeds from auction of the submitted work will be donated to charity.

### § 5 THE CONTEST PRIZES

- 1. The founder of the prizes is B-craft company Karolina Bąkowska and Aurifil producer of thread.
- 2. Prizes in the contest are:
  - Aurifil thread sets:
  - sets of branded cotton fabrics;
  - vouchers for purchases at b-craft.pl online shop.
- 3. The total value of prizes in the competition exceeds 1.200 PLN.
- 4. In order to ensure proper organization of the Competition, the Organizer appoints the selection board. Any doubts concerning the rules of the Contest, the interpretation and the provisions of these Regulations shall be settled by the Organizer.
- 5. The prize winner will be notified of the win by e-mail or telephone within five working days of the end of the Competition. Contact details will be taken from the application form.
- 6. Prizes will be sent at the Organizer's expense.
- 7. The prize in the Contest is not taxable due to its value.
- 8. There is no possibility to exchange the prize for the cash, nor can you transfer the prize to another person.

#### § 6 COMPETITION SCHEDULE

- 1. Deadlines for submissions and photos sending are 5 September 2017.
- 2. The contest will end on September 12, 2017.
- 3. The results of the Competition will be published on the Organizer's websites and on b-craft.pl facebook profile.
- 4. Exhibition of submitted works and auctions will begin in October 2017.

# $\$ 7 COPYRIGHT RIGHTS OF COMPETITION WORKS

- 1. Submission of works to the competition is equivalent to a statement of copyright of the work itself, and photographs, descriptions and designs.
- 2. Photos of contest entries sent to the Organizer give him the right to place them on the websites owned by the Organizer.
- 3. The organizer has the right to use the photos of the competition entries and the competition entries in the promotional materials and during the exhibitions promoting sewing.
- 4. In any case, which refers to §7 point 2 and §7 point 3, the Organizer undertakes to place next to the work or photo of the work, the author's data, unless the author himself expresses a clear objection to it.
- 5. The contest participant agrees to the free use of his works within the competition.

## § 8 PERSONAL DATA OF COMPETITION PARTICIPANTS

- 1. The prerequisite for receiving the prize is to provide the contestant with the real personal data necessary to deliver the prize, ie the name, surname, e-mail address, contact phone number.
- 2. All personal data entrusted to the Organizer will be collected through a secure Internet connection and with due care.
- 3. The Organizer will not share the personal data entrusted to him with another entity. Data will only be used for the smooth running of the contest.

## § 9 FINAL PROVISIONS

- 1. The Organizer has the right to change the provisions of these Regulations, unless this will impair the terms and conditions of participation in the Contest. This applies in particular to changes in the timing of particular call for proposals. The revised Terms and Conditions apply since the time it was published on <a href="bc-craft.pl">b-craft.pl</a>
- 2. Any disputes related to the contract between the Participant and the Organizer agree to settle amicably in the first place, and in cases where it is impossible for them, to submit the matter to the competent courts.
- 3. In matters not regulated in these Regulations, Polish law is in force.
